Dear R.A.C.E.S Members,

This letter is to inform you that Genesee County Emergency Management has recently received the new R.A.C.E.S cards from the State of Michigan. Over the past 5 years there have been significant changes in training requirements and emphasis on credentialing for those responding to emergency incidents. To keep Genesee County inline with these new requirements and training standards, successful completion of the following courses are needed when applying for a R.A.C.E.S card in Genesee County. The below courses can all be done online by going to <http://training.fema.gov/IS/crslist.asp>.

FEMA Independent Study Courses:

IS 100.b – Introduction to Incident Command System, ICS-100  
IS 200.b – ICS for Single Resources and Initial Action Incidents, ICS-200

Additional Independent Study Courses Recommended but not Required:

IS-700.a – NIMS, An Introduction  
IS-701.a - NIMS Multiagency Coordination System (MACS) Course  
IS-800.b - National Response Framework, An Introduction  
IS-802 - Emergency Support Functions - Communications

Other Requirements are as follows:

Valid Amateur Radio License  
Valid State of Michigan Drivers License  
Successful Background Check
